### 1) GE-2022-0214- Waiver from Certain Reporting Requirements

Due to certain changes in federal pipeline safety rules, the Missouri Association of Natural Gas Operators, Inc. (MANGO) filed a request for waiver from provisions of Commission Rules 20CRS 4240-40.020(2)(D)1.B. and (7)(B), requiring respectively reporting incidents of \$50,000 or more in property damages and mechanical fittings failure reports to PHMSA. The Commission issued an order granting the waiver on March 9, 2022, then at the request of MANGO and Staff issued an amended order on March 30, 2022 broadening the list of operators included in the waiver, and clarifying that throughout the duration of this wavier, MANGO's members are ordered to comply with the current federal definition of reportable incident contained in 49 CFR 191.3. A copy of the Amended order is attached.
