1) Proposed Rule 20 CSR 4240-40.100 Renewable Natural Gas Program

This newly proposed rule is being promulgated consistent with Section 386.895, RSMo, which directs the Commission to adopt rules for gas corporations to offer a renewable gas program, and specifically must include reporting requirements and a process for gas corporations to recover incurred costs associated with the renewable gas program that are prudent, just, and reasonable. The rule will be used by gas corporations who want to provide a renewable natural gas program.
