TELEPHONE NOTICE OF GAS INCIDENTS (09-18-2020)

20 CSR 4240-40.020, Section 4

A telephone notice is to be made to the answering service or to one of the following Missouri Public Service Commission – Safety Engineering Staff members as soon after the discovery of an incident as is reasonably possible, but not to exceed **one hour** after confirmed discover for a federally reportable incident, or **two hours** for a Missouri reportable incident, unless emergency efforts would be hindered. The answering service or these personnel may be contacted any time day or night. **The answering service can be used at any time; however, the Staff prefers operators to call the MoPSC office telephone numbers during normal working hours and home phone numbers after hours.**
