### **1) GW-2021-0355 Project and Report Completion**

The Commission opened Working Case GW-2021-0355 as a repository for documents and comments regarding development of state-wide best practices for locating quality assurance to reduce the amount of pipeline damage in Missouri resulting from insufficient locating practices.
